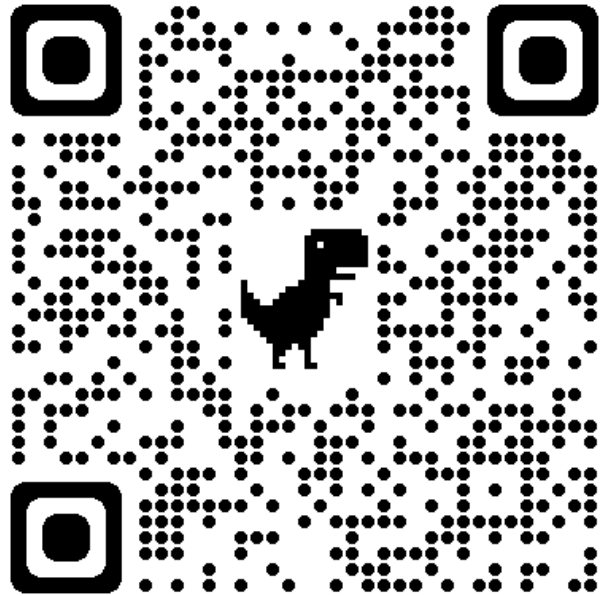

- Step 4. Show your MySOS screen when you enter Japan

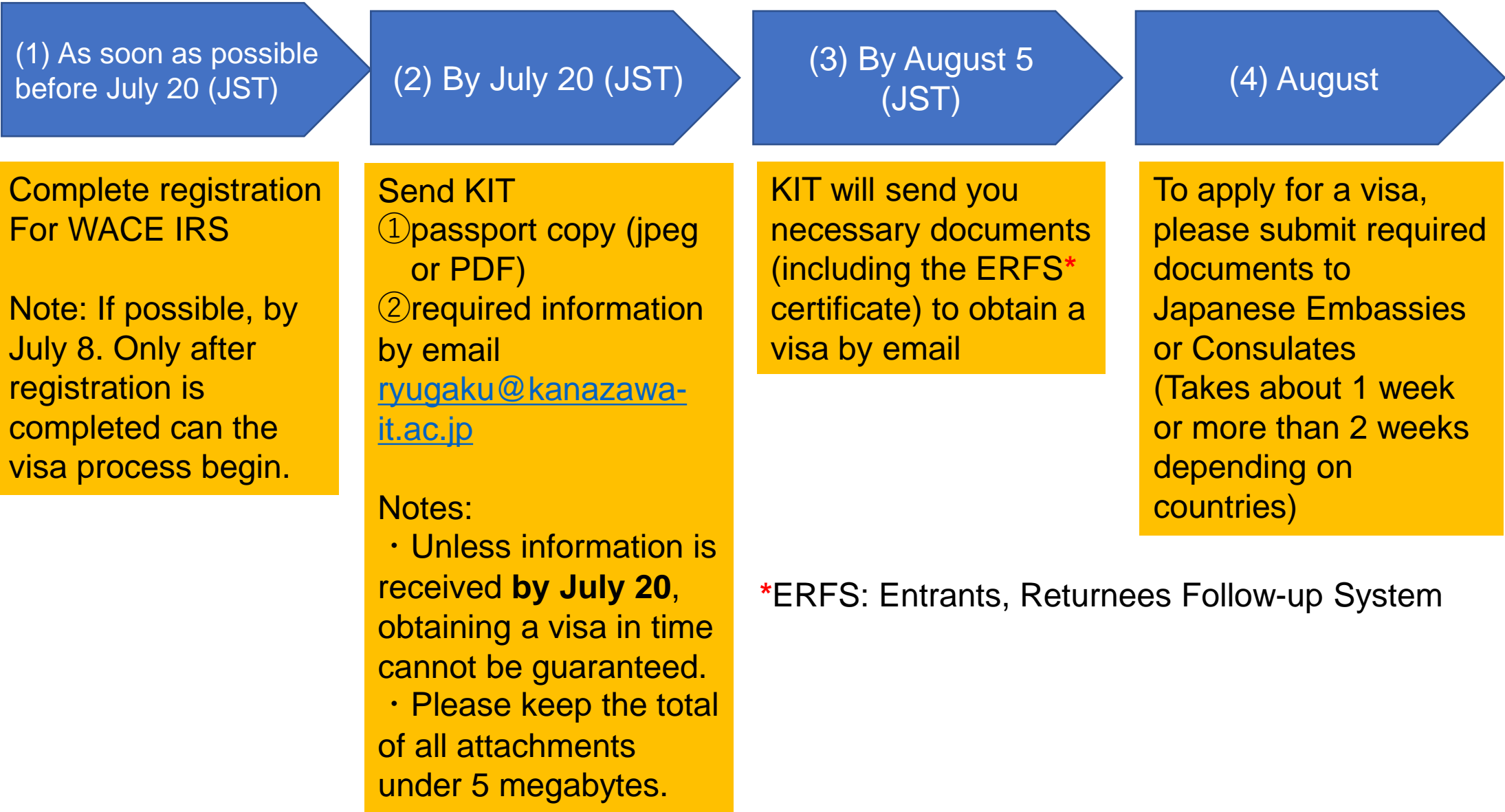
\*Required documents:

## List of Basic Documents for “Temporary Visit Visa” Application

(For Those with Nationalities **Other Than China, Russia, CIS Countries, Georgia or Philippines**)

Purpose of Visit	<b>Short-Term Business Affairs, etc.</b> (Participation in meetings, Business affairs (business liaison, business consultations, contract signing, aftersales service, market research), Cultural exchange, Sports exchange, etc.)
Documents to be submitted	<b>A. Provided by visa applicant</b> <ul style="list-style-type: none"><li><input type="checkbox"/> ① Valid Passport</li><li><input type="checkbox"/> ② 1 Visa application form</li><li><input type="checkbox"/> ③ 1 Photo (Passport Size)</li><li><input type="checkbox"/> ④ Confirmation slip/certificate/ other documents to prove reservation of air(/ship) boarding ticket or Information on planned schedule of flight (/cruise) with entry/departure date to/from Japan</li><li><input type="checkbox"/> ⑤ Proof of sufficient funds to defray all the expenses while in Japan<ul style="list-style-type: none"><li>• Travel requisition by employer or</li><li>• Letter of mission or</li><li>• Similar documents to above</li></ul></li><li><input type="checkbox"/> ⑥ Certificate of employment</li></ul> <b>B.
